**Building Healthy Communities (BHC) Program**

The Organization's Building Healthy Communities Program is one of fourteen sites throughout the State of California that focuses on impacts to economically disadvantaged areas working to build a better quality of life for residents of the Coachella, Thermal, Mecca and North Shore areas of Riverside County. The California Endowment granted funds to the Organization for activities of the BHC Program. Funds for this program service are also provided by The California Endowment's BHC Partners. The BHC Program was operated for part of the current fiscal year and was transferred to another fiscal agent in October 2014, under the Organization's separate agreement with The California Endowment.
